FC 116/16 The disciplinary, capability, sickness absence and grievance policies and procedures previously agreed by the Governance Working Group on 13 September 2016 were **adopted**. As suggested at that meeting, the documents were discussed with staff at the 18 October 2016 staff meeting.

WEST HERTS HOSPITALS

FC 117/16 The draft letter to David Gauke MP expressing the Town Council's disappointment that the Herts Valley Clinical Commissioning Group has ruled out the relocation of Watford Hospital services to a Greenfield site was discussed.

FINANCIAL MATTERS

FC 118/16 **Christmas Lights 2017**

It was noted that both Berkhamsted Town Hall Trust and Berkhamsted and District Chamber of Commerce have each pledged a donation of £500 towards Christmas lights and the work required to install feeder columns in the High Street.

FC 119/16 **Councillor Allowances, Travel and Subsistence**

- To **note** that following recent informal discussions within the Town Council, the Town Clerk has confirmed through NALC that Parish and Town Councillors may be paid allowances in respect of travelling and subsistence. This power is not constrained by parish boundary considerations.
- It was **RESOLVED** that the Town Clerk should prepare guidance specific ii. to the Town Council for adoption at a future meeting. This guidance should also include the procedure regarding the provision of stationery and other office supplies for council business use.

FC 120/16 Section 1 of the Public Bodies (Admission to Meetings) Act 1960, exclusion of the press and public.

FC 121/16 Civic Centre Lease – January 2016 for a four year term

It was **RESOLVED** that, following discussions with Dacorum Borough Council regarding service charges and DBC's agreement to cap such charges, the Town Mayor and Cllr G Stevens are authorised to sign the lease on behalf of the Town Council once the promised final version is received. In the interim the Town Clerk will seek clarification on the impact of clause 15 "Joint and several liability".

FC 122/16 Land Ownership – Land adjacent to Normandy Drive and Dellfield **Allotment Site**

Cllr Ritchie advised that a meeting would be held with DBC representatives in the New Year to discuss ownership and registration of the site. In the meantime it was RESOLVED that the Town Clerk would seek further legal guidance from the Council's solicitor and consider the various options open to the Council in the light of this advice.

FC 123/16 Staffing matters

It was **RESOLVED** that the Town Warden should move from salary point 18 to salary point 19 with effect from 1 January 2017 which is the anniversary of his appointment to point 18 LC1 Substantive Benchmark range. The Town Clerk would write to the Town Warden confirming this change.
