



EXPLANATORY NOTE

Following public consultation, Hertfordshire County Council has recently made an Order to divert Berkhamsted Footpath 61 to outside the Groundsmen's maintenance compound.

The Order can be seen at www.hertfordshire.gov.uk/rowapps. Look under "B" for 'Berkhamsted, Chesham Road Cricket Ground, DAC174DIV'.

The adjoining Notice describes in detail the changes being made to Footpath 61 and the effect of these changes is shown on the plan. The changes to the Footpath have to be advertised before they can take legal effect which is why the adjoining Notice is on display.

Anyone who wishes to comment, either in support or opposition to the Diversion Order should do so according to the instructions in the adjoining Notice.

NOTICE OF MAKING OF A DIVERSION ORDER

HIGHWAYS ACT 1980, SECTION 119

HERTFORDSHIRE COUNTY COUNCIL (BERKHAMSTED 61) DIVERSION ORDER 2022

The above Order made on 15th September 2022, under section 119 of the Highways Act 1980 will divert the public footpath:-

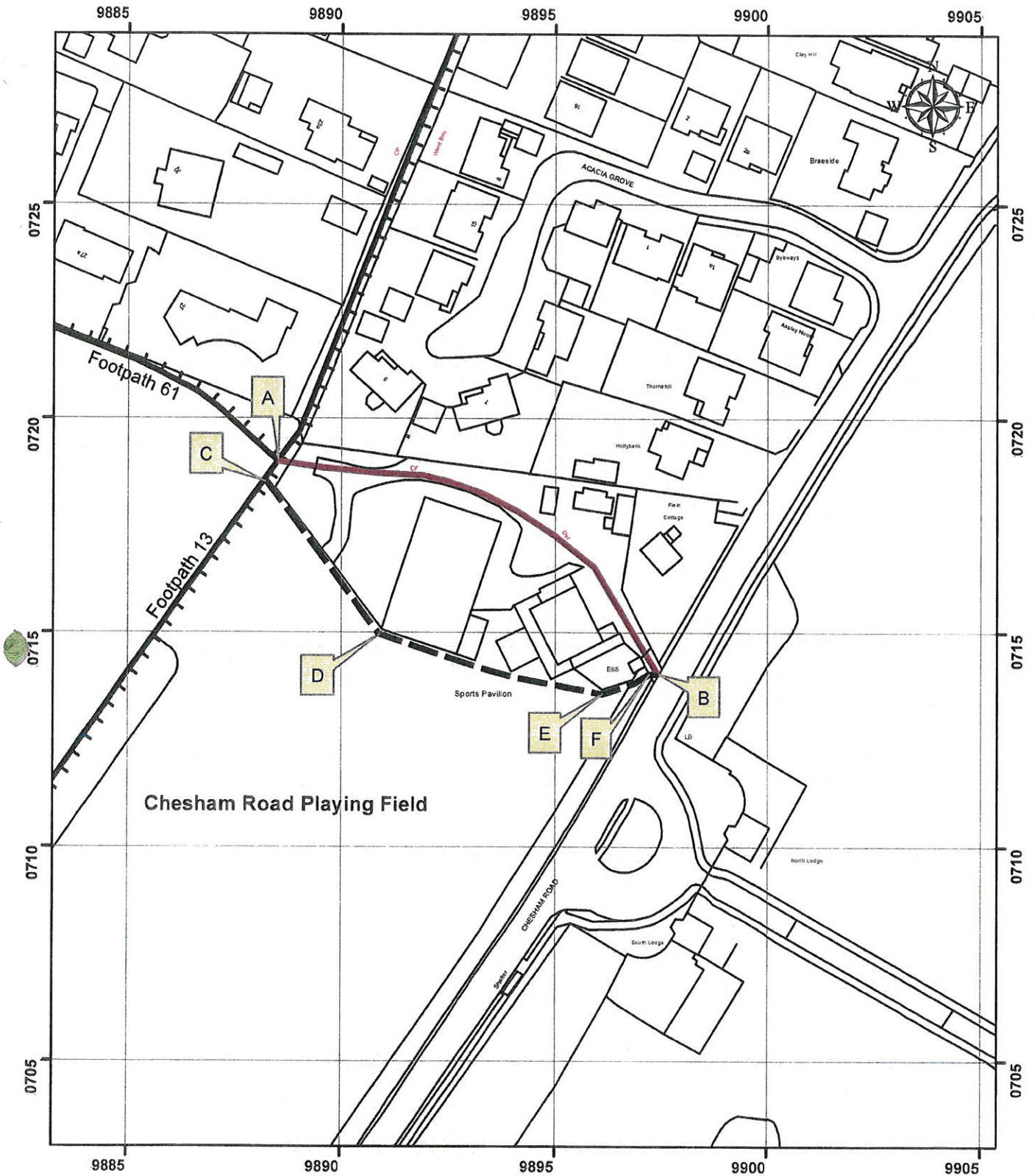
- running from Berkhamsted Footpath 13 at SP 9888 0719 (point A on the Order Plan) east and south east following the drive between Field Cottage and the Sports Pavilion for approximately 110 metres to a junction with Chesham Road (public road) at SP 9897 0714 (point B on the Order Plan); to a line
- commencing from a junction with Berkhamsted Footpath 13 at SP 9888 0718 (point C on the Order Plan) then south easterly on the north side of the Chesham Road Playing Field, on the south west side of the maintenance compound boundary, for approximately 45 metres to SP 9890 0714 (point D on the Order Plan). Continues east south east, to the south of the Sports Pavilion, for approximately 55 metres to SP 9896 0713 (point E on the Order Plan). Continues east north east, on the south east side of the boundary, for approximately 10 metres to exit the Playing Field at SP 9897 0714 (point F on the Order Plan) and join Chesham Road (public road) at SP 9897 0714 (point B on the Order Plan).

If the Order is sent to the Secretary of State for the Environment for confirmation any representations or objections which have not been withdrawn will be sent with the Order.
