THE HERTFORDSHIRE (TEMPORARY CLOSING AND TEMPORARY WAITING RESTRICTIONS IN VARIOUS ROADS IN BERKHAMSTED, FLAMSTEAD AND HEMEL HEMPSTEAD) ORDER 2021

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads ("the Roads"), except for access and to prohibit all vehicles from waiting at any time on both sides of these lengths of Roads whilst works are in progress:-

1. that length of Station Road/Lower Kings Road, Berkhamsted from its junction with Castle Street north westwards and south westwards for a distance of approximately 430 metres.

An alternative route will be via Station Road, Gravel Path, Ravens Lane, A4251 High Street and Lower Kings Road.

2. that length of River Hill, Flamstead from its junction with A5183 London Road north eastwards to its junction with Old Watling Street, a distance of approximately 133 metres.

An alternative route will be via A5183 London Road and Old Watling Street.

3. the parking area situated on the west side of No.1 Cambrian Way, Hemel Hempstead from its junction with Cambrian Way north westwards for its entire length.

There is no alternative route available for vehicles when the works are being carried out. However vehicular access to properties in this road will be maintained whenever possible throughout the duration of the works.

The Order is needed because works are proposed to be executed on or near the Roads.

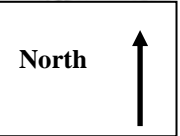
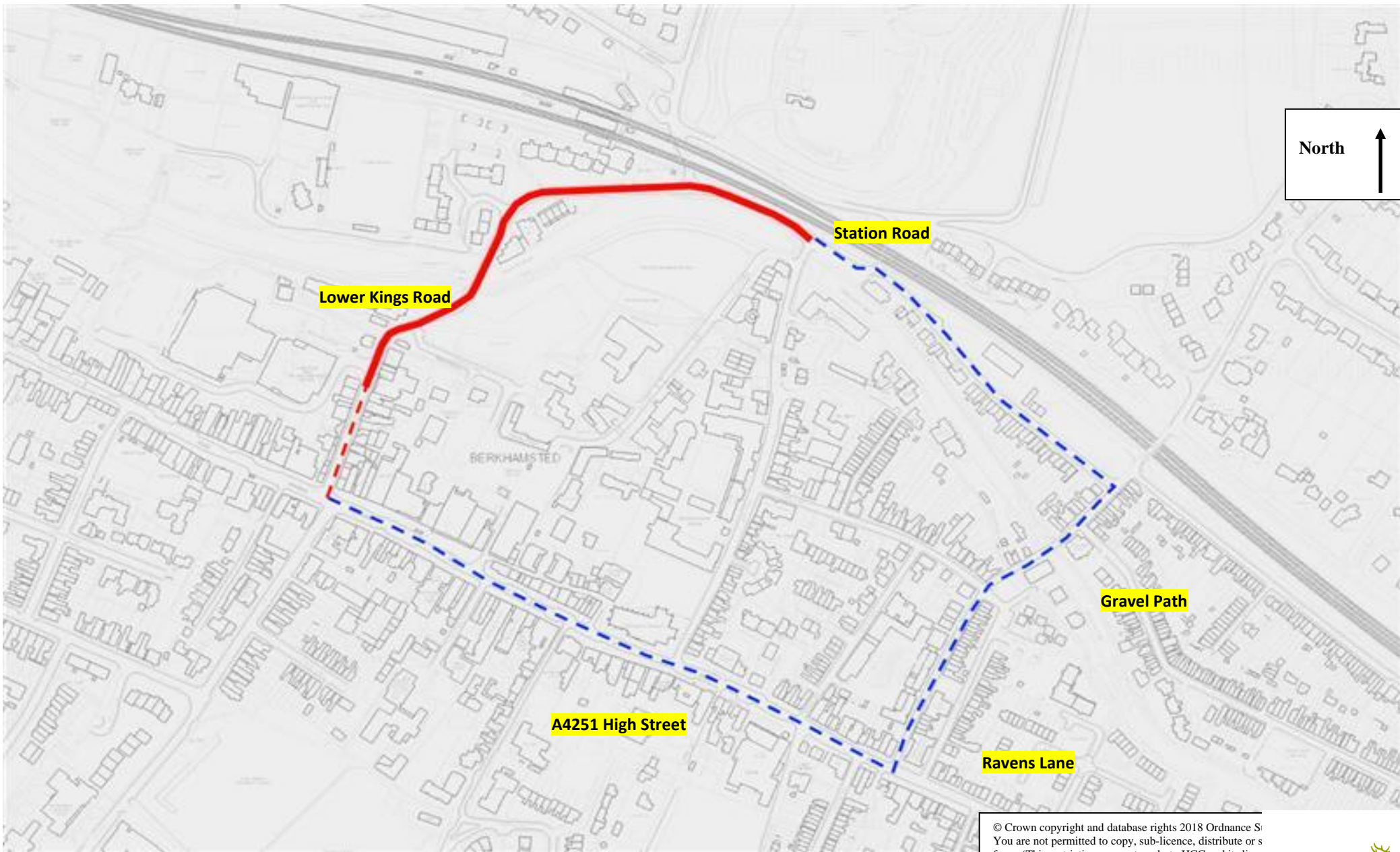
If the Order is made, it shall come into force on 19 April 2021 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).
