TP 04/18 Chair's Communications

Road Traffic Orders

- i. Notification has been received from Hertfordshire County Council of the temporary closing of Rectory Lane from its

junction with the A4251 High Street south westwards for a distance of approximately 171 metres (the Road), except for access, from 13 January 2018 for a period of up to 18 months. However, the restrictions will only take effect at the times indicated by signs on or near the Road.

There is no alternative route available.

The Order is needed because gas service works are proposed to be executed on or near the Road.

- ii. Notification has been received from Hertfordshire County Council of the temporary closing of Hilltop Road from its junction with Chesham Road south eastwards for a distance of approximately 33 metres (the Road), except for access from 19 January 2018 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Road.

An alternative route will be via Chesham Road, A416 (Kingshill Way/King Road), A4251 High Street, Swing Gate Lane, Woodlands Avenue, Beech Drive and Hilltop Road.

The Order is needed because the replacement of existing sewer covers are proposed to be executed on or near the Road.

4/02581/17/FHA Removal of front boundary wall at 257 High Street. (JS)

Objection.

The proposals would be inappropriate in this Conservation Area setting and out of keeping with the street scene.

4/02685/17/FHA Rear dormer. Roof light to rear elevation at 11 Kitsbury Road. (BC)

Objection.

This is an inappropriate development in the Conservation Area and the proposed rear dormer would be overly dominant in terms of scale, bulk and mass.

The Chair suspended standing orders to enable Mr P Lloyd, an adjacent neighbour, to speak. He objected to the proposals which were overbearing, intrusive and would subject his property to overshadowing. In addition, there would be overlooking of his property lengthways and also from the side window.

Thanking Mr Lloyd for his contribution, the Chair reinstated standing orders.

Objection.

The window in the side elevation would result in overlooking of the neighbouring property with a consequent loss of privacy. The overall bulk of the proposals would also result in overshadowing and a loss of light to the adjoining neighbours who have lived in their property for over 30 years. The bulk, mass and scale of the development would cover a large proportion of the roof and would therefore be wholly out of keeping with the street scene and the Conservation Area.
